- Involvement in any activity that may be of an immoral or degrading nature is unacceptable behavior.
- The historic and current commitment to the ideal of intellectual, spiritual and physical wellness precludes the use of tobacco, alcohol or any other controlled substance during GBLC and university related activities.

I understand that willful neglect of this agreement may result in my being sent home early at my own expense and I will forfeit all other funds that have been paid.

Waiver, Release of Liability, Indemnification and Consent Form

Since Global Business Leadership Center (GBLC) is a non-profit organization and in the nature of the case does not and cannot assume responsibility in the event of sickness and/or accidents involving voluntary participants;

Now therefore I, the undersigned, being over 18 years of age, will participate in the program and acknowledge that I am not an employee, servant or agent of the GBLC. As a participant, the organization is not responsible for sickness, accidents or other mishaps, serious bodily injury, permanent disability or death (whether or not caused in the whole or in part by negligence of the misconduct of the organization or individual mentioned above) and understands that I must make my own provision for such eventualities, release GBLC and any and all of their departments, officers, agents and employees from all claims and demands in connection with my participation with GBLC. This agreement is binding upon the heirs, executors and assigns of the persons signing this form.

I will not hold GBLC and any of their departments, officers, agents, employees or volunteers responsible for any accident, injury or illness resulting from my participation, nor for the loss of or damage to personal property while participating in a global forum trip; and I will indemnify and hold harmless the GBLC from and against any and all liability caused by my participation.

I also give the GBLC and his/her assigns, licensees and legal representatives the irrevocable right to use my picture, portrait or photograph in all forms of media and in all manner, including electronic media and/or composite representations, for advertising, trade or any lawful purposes; and I waive any right to inspect or approve the finished product, including written copy that may be created in connection therewith.

Invalidity/Unenforceability: If any provision of this form is held to be invalid or unenforceable, this form shall be construed as if such invalid or unenforceable provision was not contained herein.

Medical Release, Insurance and Permission to Treat

Overseas Health and Overseas Accident Insurance:

Travelers' insurance is required for each participant. GBLC will purchase coverage on your behalf underwritten by Brotherhood Mutual's Passport to Ministry Program (including all travel days). The policy includes limited medical assistance, emergency evacuation and repatriation GBLC does not cover costs of your personal medical coverage for illness or accidents. Each participant will receive a copy of the policy provided by GBLC..

I the undersigned, hereby agree as follows: In the event of any accident, sudden illness or medical emergency involving myself in connection by the Global Business Leadership Center, I hereby authorize leadership and staff examination, anesthetic, medical or surgical diagnosis or treatment and hospital care deemed to be necessary by a licensed physician and agree to accept full financial responsibility for these services.
